INSTRUCTIONS FOR PREPARING ABSTRACTS AND PAPERS

Abstract:

Paper title: up to 70 characters with spaces

Abstract: up to 1200 characters with spaces, including maximum 5 key words.

Paper: 8 pages, including the abstract (a maximum of 15,000 characters with spaces).

The program for preparing the text and tables is Word for Windows and Corel Draw for figures. The title of tables or figures is located above and the source is located below, written in Times New Roman 12 pt font.

The title page of the paper

Paper title: Times New Roman 12 pt font, bold, centred.

The author's name and surname: Times New Roman 12 pt font, bold, centred.

Employer: Times New Roman 12 pt font, bold, centred.

The text of the paper

Chapter title: capital letters, Times New Roman 12 pt font, bold.

Subchapter title: Times New Roman 12 pt font, bold.

Text: Times New Roman 12 pt font, justified.

The paper should be written in A4 format, where the left, right and top margins are 2.5 cm and the bottom margin is 3 cm. Page numbers, except the first page, are centred.

When structuring their papers, authors should adhere to the IMRAD methodology (Introduction, Methodology, Results and Discussion, meaning that the paper should be divided into the following parts in terms of its content: introduction, methodology, results, analysis and, finally, discussion or conclusion).

When citing sources in their papers, authors should mention the first and second author as well as the year of publication (Novak and Smithers, 2006) or the first author and 'et al.' in the event of three or more authors (Zigler et al., 1991).

There should be a space of two lines between the text of the paper and the mention of sources. *The list should only include the sources to which you refer in your paper.* The list of references should be arranged in alphabetical order of authors as follows:

- *for books:* surname and name of the author, publication year, title, place, publisher. Example: Samuelson, P. A. and Nordhaus, W. D. (2010). Economics. Boston: McGraw Hill.
- *for articles in journals:* surname and name of the author, publication year, article title, journal title, volume, number, pages. Example: Mauer, P. (2013). V posel s treznim premislekom. Podjetnik, 22, No. 7/8, pp. 52–55.
- *for articles in proceedings:* surname and name of the author, publication year, article title, information about the book or journal, pages. Example: Senjur, M. (2009). Strategija razvoja Slovenije in gospodarska recesija. In: Nared, J. and Perko, D. (ed.). Razvojni izzivi Slovenije. Ljubljana: Založba ZRC, pp. 21–28.
- *for online references,* it is compulsory to state the exact website along with the name of the document and the date of finding information. Example: Gostiša, M. (2001). Vloga kadrovskih služb pri razvoju delavskega samoupravljanja. Available from: <http://www.delavska-participacija.com/clanki/vlogakadrovsluzb.doc> [Retrieved 25 June 2006 at 17.30].
