Znanje in razumevanje:

Študent/Studentka:

- pozna in razume zgodovinski razvoj politik;

Intended learning outcomes:

Knowledge and understanding:

Students:

- know and understand the historical development of policies
- know and understand the theoretical foundations on which the policies of the European Union are based;
- know and understand the EU policies of all member states, and the policies in which the European Commission has a coordinative role within the member states;
- know and understand the methodological and content framework of policies and its usefulness in learning about economic processes and management processes;
- assess the effectiveness of EU policies and guidelines in formulating national policy strategies;
- analyse and compare each sectorial policies and indicate their interactions;
- analyse the results of the national accounts, structural indicators and other data produced by Eurostat;
- the ability to classify Slovenian strategies in specific fields within the framework of European Union policies.
